BRING & BUY CONDITIONS

1. The club reserves the right at its sole discretion to refuse to accept and /or sell any items submitted by the owner.

6. In the event of payment being offered by cheque the purchaser will be required to present some form of identification, and TWO separate cheques:
 - a) One payable to the owner for 90% of the selling price.
 - b) One payable to Wythall Amateur Radio Club for 10% of the selling price.
7. Cheques will be accepted at the sole discretion of the club. Where payment is made by cheque the owner shall be obliged to accept that cheque, if any cheque is subsequently stopped or dishonoured, the club shall be under no liability to the owner.
8. All items are sold as stated overleaf and the club gives no warranty as to the condition, description and/or fitness for the purpose of any item offered for sale.
9. **THE CLUB DOES NOT ACCEPT LIABILITY FOR:**
 - a) Any Loss or Damage to any one or more items, however caused.
 - b) Any Loss resulting to the owner by reason of inaccuracy in the owners description of any item.
10. **THE CLUB RESERVES THE RIGHT:**
